

## AGREEMENT ON TERMS AND CONDITIONS OF TUITION PAYMENTS

entered into on **2023-11-14** between:

- Ms./Mrs./Mr **Jisma Placid, Y5587004** further referred to as the **Student**, and
- **University of Economics and Human Sciences in Warsaw** (address: 01-043 Warsaw, 59 Okopowa Street), listed in the register of non-public universities kept by the Minister of Education and Science, entry number 261, hereinafter referred to as the University, represented by **General Director** Marzena Godlewska

### § 1

The subject of this Agreement is to specify the terms and conditions of tuition payments for full-time studies MA studies Psychology ("Studies").

### § 2

1. The **Student** shall be obligated to pay tuition fees required for the studies in the amounts and on dates indicated in the Attachment to the present **Agreement**.
2. The Parties agree that the payment method selected in the present Agreement shall remain binding in the whole duration of the Agreement. Should the **Student** wish to change the payment method for the following academic year, they shall be obligated to declare their will in writing prior to the beginning of the new academic year.
3. The Student shall be obligated to pay an admissions fee and an administrative charge subject to conditions established in the **Attachment** to the present Agreement.
4. The Student shall be obligated to pay extra charges as established in legal acts implementing the Law on Higher Education and Science.
5. The payment date shall be considered the day on which the amount paid is credited on the University's bank account or the day on which the amount in cash is paid at the **University's** cash desk.
6. The Student shall be obligated to present the payment confirmation upon request of the University's authorized employees.
7. The **University** shall charge interest for late payments, which shall amount to double the legal interest rate. However, the sum shall not exceed the maximum interest rate as established in the Polish Civil Code.

### § 3

1. The Student shall be obligated to notify the **University** in writing should his or her personal data included in the present **Agreement** change. Should the **Student** fail to comply, any and all consequences shall burden the **Student**.
2. The **University** shall be obligated to notify the Student should its address included in the present Agreement change. Should the University fail to comply, any and all consequences shall burden the **University**.

### § 4

1. The Agreement shall expire when the **Student** graduates or when the **Student** is removed from the register of students.
2. Each Party may terminate the **Agreement** at any time with a one-month notice, effective at the end of the calendar month.
3. The present **Agreement** may be terminated only by submitting a written declaration to the other Party with acknowledgement of receipt.
4. The **University** may terminate the **Agreement** should the **Student** fail to comply with his or her obligations resulting from the present **Agreement**.
5. Termination of the present **Agreement** shall be equivalent to the removal of the **Student** from the register of students.

### § 5

1. Any modification of the present **Agreement** shall be made in writing under pain of nullity.
2. The Attachment constitutes an integral part of the **Agreement**.
3. To all matters not settled in the present Agreement relevant provisions of Polish law shall be applied.
4. All conflicts resulting from the present **Agreement** shall be subjected to the jurisdiction of common courts.
5. The **Agreement** has been drawn up in two identical copies, one of which is given to each Party.
6. The **Student** acknowledges and accepts that classes at the University may be conducted with the use of distance teaching methods and technologies. Should it prove necessary to conduct classes in such a way, distance learning will be implemented regardless of the fact if it has or has not been included in the programme of the **Studies**. Distance learning shall not influence the tuition fees for the Studies which the **Student** is obligated to pay pursuant to the present **Agreement**.

# Attachment to the Agreement on terms and conditions of tuition payments entered into on 2023-11-14

## 1. Tuition

- 1) The Student shall pay the **tuition** required for the Studies.
- 2) The Student is awarded a discount of **0 EUR** in the tuition for the first year of the Studies.
- 3) The **tuition fees** due for the Studies, after applying discounts and deductions, and the due dates are as follows:

### I year of study

**The total tuition per academic year: 3900 EUR**

Annual payment In the amount of **3900 EUR** until 10 september 2024 .

### II year of study

**The total tuition per academic year: 3900 EUR**

Annual payment In the amount of **3900 EUR** until 10 september given academic year .

## 2. Administrative charge and admissions fee

The Student shall be obligated to pay the following administrative charge and admissions fee:

- a. The administrative charge is **200 EUR** ,
- b. Admissions fee is **20 EUR**
- c. The Student is awarded a discount as regards the administrative charge of **0 EUR**
- d. The total sum of the above-mentioned payments after applying the discount is **220 EUR**
- e. The Administrative charge and the admissions fee are due no later than on the day the present Agreement is entered into

## 3. Payments in case the Agreement is terminated

Should the Agreement be terminated, the Student shall be obligated to make, in full, all payments due to the University within seven days from the termination date, provided that the sum of payments that he or she has so far made to the University is lower than the sum of payments due for the Studies.
