

GENERAL TERMS AND CONDITIONS

- The amount of tuition is set for the current year.
- The amount of the tuition fee covers the cost of studies within the framework of the organization defined by the Management of the Institution. No additional fees are due for tests organized within the institution during the school year.
- The tuition fee includes photocopies provided within the strict framework of the course (teaching material only provided by the instructor).
- Tuition fees do not include CVEC, health insurance membership, personal school supplies, and contributions to student associations.
- Enrollment will be final only after receipt of this agreement, payment of the full tuition fee, and the mandatory payment of the CVEC.
- The student card and certificates of attendance will then be given to the student.
- Students are insured against accidents at the Institution in accordance with the terms of the insurance policy taken out by the Institution.
- The Institution undertakes to provide instruction in the form, date and location of classes throughout the day as determined by the Institution. However, it reserves the right to modify the timetable.
- ◇ Fees is non-refundable in the event of disqualification termination or lack of attendance and discontinue of study for whatsoever reason.
- Only students who have paid full first year fees will be allowed to attend the class in which they are registered.
- Students must be enrolled in a school in Paris, and may not transfer to another school during the year. A transfer to a school in the Ecole Conte network is possible, after a pedagogical commission, at the end of the first year of the program in Paris.
- Once the visa has been obtained, if the student does not show up at Ecole Conte, or if the student does not show up at Ecole Conte to start the course, the tuition fees are due in full without any possibility of reimbursement.
- Each student will carry out the compulsory internships and will confirm to the internal rules of the institution. The internship agreements signed by the company tutor and the student must be VALIDATED and returned to the establishment BEFORE the internship begins. Failure to do so will result in the student not being registered for the exam, without any reimbursement of tuition fees and without any possible exception.

REFUND POLICY:

- ◇ In case of Visa Refusal: Administrative Cost is non-refundable.
- ◇ Paid Tuition Fees is completely refundable only in after submission of valid documents for Visa Refusal issued by France Embassy.
- ◇ Fees is not refundable in the event of non-submission of visa
- ◇ Tuition Fees will be refunded within 60-70 working days after Intake begins.

Any unexcused absence of the student for more than two consecutive weeks will be considered as a definitive termination of the present study contract, without refund. The school will then inform the French embassy which will lead to the withdrawal of the student visa.

In the event of cancellation or termination of enrollment at anytime, the balance of the amounts due under this Agreement is immediately due and payable. This provision is also applicable in case of withdrawal from the course during the year.

THE BENEFIT OF ALL THESE ADVANTAGES WILL BE ACQUIRED AS LONG AS THE CONDITIONS OF THE PRESENT AGREEMENT, AS WELL AS THE SCHOOL'S RULES AND REGULATIONS ARE RESPECTED.


