Please, confirm your attendance. If we do not receive your confirmation in two working days, the appointment slot will be deleted. Note and respect the time of the appointment. Applicants who do not confirm or come in time will lose their appointment slot and will have to apply again. At the appointment, you are required to present your passport for the identification. Consular and Visa Office conducts business in Slovene, English, Hindu and Tamil languages only. For other languages, the applicants need to provide the correspondent translation.

Please note that the amount shown on the embassy's balance sheet must be identical to the amount of the fee, so we recommend that customers pay the tax based on the calculation issued by the embassy when the service is rendered.

Article 90 of The Aliens Act (Obligations of aliens in procedures) (1) Aliens must cooperate with the competent authorities throughout procedures and must comply with their measures. Aliens must enable access by the competent authorities to all available evidence, submit all documents and confirmations which they possess and which may be relevant to procedures, and respond to invitations by the competent authorities. The competent authorities may set a suitable deadline by which aliens must submit all documents, confirmations and other evidence required; otherwise they shall not be obliged to take this evidence into account.
