After settling the payment with Flywire, you will receive the enrollment pack including the enrollment letter and the documents you might need for visa application by email.

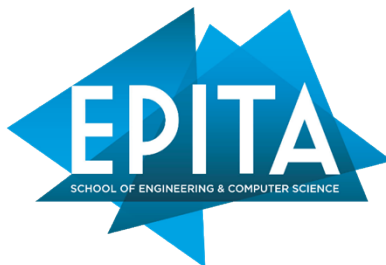
