- 3. E-Mail ID: An E-mail id will be created for the admission and visa process.
- 4. Address for Communication: Our address will be used for applications for communication.
- 5. <u>Application details:</u> Ozone will apply to 5 Universities which will be a combination of Technical Universities(TU)& Fachhochschule(FH), based on student's requirements and qualification.
- 6. <u>Blocked Account:</u> Students must be aware of blocked account, where an amount equivalent to 11208 Euros need to be transferred to student's German account. (11208Euros might vary if there any changes occur).(APS Certificate payment approximately Rs.18000 is mandatory.)
- 7. Regarding Accommodation: Getting accommodation is very difficult, so students have to directly interact with the University to secure the same after receiving the offer letter. If the University is not providing the accommodation, Ozone will guide to book a private hostel for a week time. The expenses should be borne by the student.
- 8. <u>Airport pickup Facilitation:</u>No German University will provide Airport pickup. Ozone will provide travel guidance in the form of Route Map's, Bus Route, etc; to reach from Airport to University. The expenses incurred should be taken care by the students.
- 9. <u>Regarding Admission and Visa</u>: Success of Admission and Visa lies at the sole discretion of the University and the Embassy. Ozone can only provide complete guidance and assistance.
