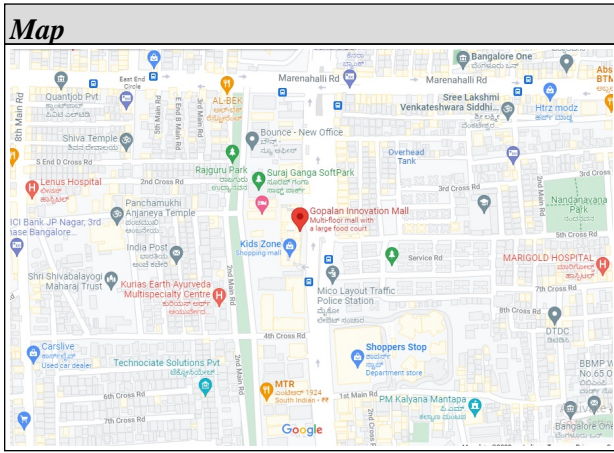
Apart from the safety procedures conducted, please note that

- 1.Limited number of customers will be allowed inside the Visa Application Center at a time, therefore please ensure you arrive at your stipulated appointment time.
- 2.Wearing a mask within the Visa Application Centre is mandatory.
- 3.Customers are requested to complete the Courier formalities as post decision passports will only be returned by courier as mandated by the Consulate General of Germany in Mumbai. Applicants will not be permitted to visit the Visa Application Centre for collection of passport.

If you were vaccinated in India with Covishield, please note that your vaccination certificate must contain your passport number or date of birth. Reference to Aadhar number is not sufficient.
