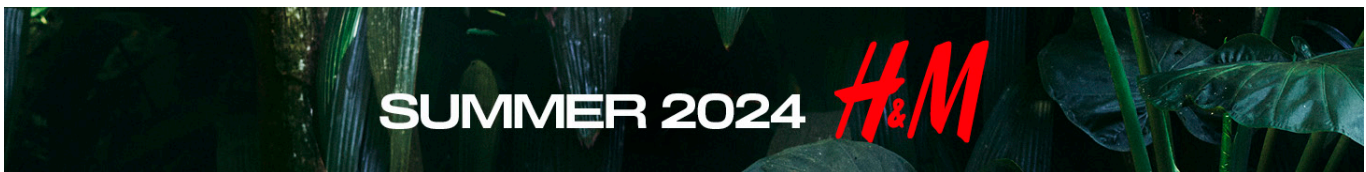

IMPORTANT INFORMATION

- **Check-in Time** : We advise you to reach the airport atleast 4 hours before departure. Check-in counter generally closes 120 minutes before scheduled departure. It may vary from airline to airline and so it is advisable to check with the airline once.

- **Please Note** : Passengers travelling on a tourist visa or visit visa are not allowed to travel with one-way ticket. They must show a confirmed return ticket else they may not be allowed to board the flight.
