4. The State Government shall not have any liability on you as an employer.

5. There will be special training before joining the job.

If you agree to the above instructions and are ready to start work, you should appear before the General Manager of Malappuram District Industries Center on 16/10/2023 and start work. If you do not join the work on the date mentioned above, your appointment will be considered void without further notice.

The originals of the documents proving your eligibility should be produced before the General Manager of the District Industries Centre. Appointment will be allowed only after verification of the documents. If the documents submitted by you are found to be forged or fake, the appointment will be canceled without further notice and legal action will be taken. Also, if any corruption, misconduct, lack of commitment to work or incompetence is noticed, your contract will be terminated without further notice.

If you are going to work, you will have to enter into a Memorandum of Understanding with the General Manager of the District Industrial Centre. 200/- stamp paper taken in your name should be produced on the day of joining the job.
