The second case is about an application filed before the Hon'ble High Court of Judicate, at Delhi, for an anticipatory bail of an accused Shri. Manish Prajapati. In this case of Manish Prajapati vs. State of Delhi & NCT, a criminal case was registered under section 354, 354 D, 506 & 509 IPC against the accused, and the petition filed for anticipatory bail was dismissed by the District and Sessions Court in Delhi. Finally, anticipatory bail was granted by the Hon'ble High Court of Judicature at Delhi with conditions imposed on the accused.

During the period of internship Miss. Aaliya Sajeed demonstrated good skills with a sense of legal acumen and a self-motivated attitude to learn new things. Her performance exceeded expectations and was able to complete internship successfully.
