IMPORTANT NOTICES

1. We regularly check the attendance of students and their performance. Students not actively studying will have their Temporary Residence Permit (TRP, "visa") revoked and will be deported without delay.
2. Despite any supplementary information students may receive, it is important to note that the study program is rigorous and demands the full attention and dedication of the student. Our commitment involves assisting students in every conceivable manner to ensure they meet their academic responsibilities. The classes are organized primarily in the afternoon and based on the requirements of the study program. The class hours will not be tailored to individual students' needs.
3. Erudio Education group will only charge the tuition fees and inscription fees. The students must follow strict deadlines for payments provided by the School's appointed Consultant to secure enrollment on time and prevent any processing delays.
4. The processing time from the application to granting of the temporary residence permit can exceed several months. The School does the recognition of studies. The TRP (visa) is processed by the Government of Slovenia (Immigration Unit, Embassy) upon submission of the complete documentation. The visa interview slots are handled and scheduled by the Embassy. We, at ERUDIO Education group cannot influence the decision of the authorities. The processing time also depends on the quality and expediency of the papers provided by the students to the Consultant. Please follow the instructions and deadlines given by the Consultant.
5. The student shall receive his/her "ERUDIO Student Digital Identity" by the 31st of October at the latest. Please get in touch with your Schools appointed Consultant if you have not received it on time (see next point).
