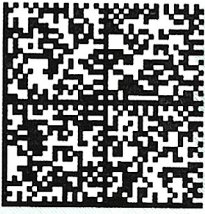

Consequently the High Power Committee appointed by Government of Andhra Pradesh has recommended for release of Results of SSC Public Examinations March 2020 on the basis of the Internal Examination Marks for awarding Grades and Grade Points as per G.O.Ms.No.46, School Education (Prog. II) D.O. No. 1071, Dated 02.08.2021.

The Government of Andhra Pradesh Finally Re-Introduced the system of awarding marks and Divisions by dispensing with Grades and Grade Points from SSC Public Examinations March 2020 onwards to G.O.Ms.No.55, School Education, D.O. No. 1071, Dated 02.08.2021.
