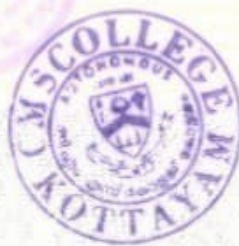



## DESCRIPTION OF THE EVALUATION PROCESS

### Grade and Grade Point

The Evaluation of each Course comprises of Internal and External Components in the ratio 1:4 for all Courses. Grades and Grade Points are given on a 10-point Scale based on the percentage of total marks (ISA + ESA) as given in Table I.

### Credit Point and Credit Point Average

Credit point (CP) of a paper is calculated using the formula  $CP = C \times GP$ , where **C** is the Credit; **GP** is the Grade Point

Credit Point Average (CPA) of a Course/ Semester (SCPA) or Programme (cumulative) (CCPA) etc. is calculated using the formula

$$CPA \text{ or } CCPA \text{ or } SCPA = \frac{TCP}{TC}$$

where TCP is the Total Credit Point, TC is the Total Credit
