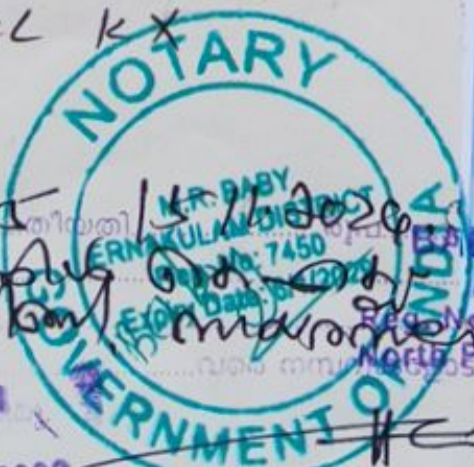

4. I undertake to financially support all his educational, living, and other related expenses during his entire period of study at International Business School, Vienna campus, Austria.

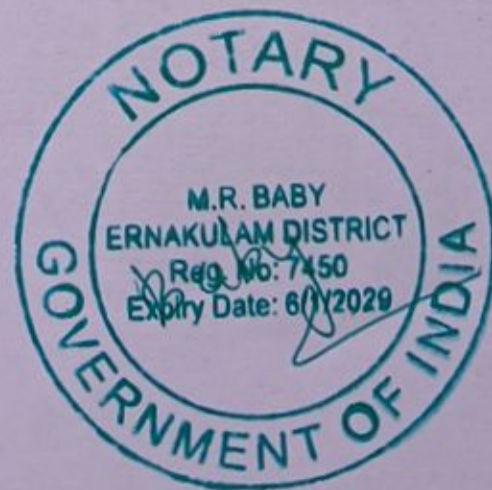
5. I have sufficient funds and resources to cover his tuition fees, accommodation, health insurance, and living expenses in Austria during his academic term.

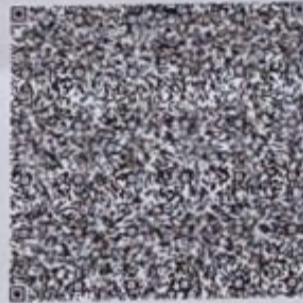
