I) Category : General Questions

- Introduce yourself and provide a brief background.
 - Prepare a neat, self-introduction with very basic's about personal information and more about the professional seeks, and a brief describing why you are seeking this particular program.
- · Why do you want to do this course?
 - Describe the reasons for choosing this particular program
 - Refer to details from the website and all available sources
 - Benefits
 - Career progression
 - Syllabus
 - Scope of the program
 - Connect with your previous exp / study with the chosen course

Why did you choose this college?

- Note: Refer institute website to prepare points also candidate needs to compare similar courses with other institutes in Malta.
- If the same course happens to be in another institute with a low fee, then candidates must prepare points focusing on the teaching quality level, other facilities, amenities, location, college ratings, testimonials, and Google reviews.
- Refer to "about us" on the institution's website.





Why do you want to study in Malta?

Give a brief about the advantages of learning in Malta, like - Fee,
 Duration, Climate, Low Living Cost, Standard of Education, Culture,
 Beauty of the country, Low Crime Rate, Multi-lingual country, One
 and only one English-speaking country in EU countries, and
 Opportunity to visit around EU Countries.

Why can't you do the same course in India?

 Studying in India will not give an exposure like taking an international education. Studying in India gives less chance to learn new cultures and international and professional standards, Studying in India gives Less opportunity to learn other international languages, Studying in an international country will give CV weightage and better improved global professional skills.

Which are the main organizations in which you can work?

- Learn about the possible industries and designations that you can choose for a job opportunity.
- What salary will you get after the course?
 - Find the average pay scale in the possible jobs after the course
- Do you have any visa approval/rejection or previous PCC (police clearance certificate) in your passport?
 - Answer genuinely





II) Category: Course Details

- Course start date, end date, level, credits, and assessment methods.
 Explain each module in 1 or 2 sentences.
- Tuition Fees Paid, Mode of payment
- Refund Policy of the college
 - Collect all the details related to the above questions from either the Institute website or from the agency always referring to genuine information rather than from unofficial websites.

III) Category: Institution Details

- What is the postal address of the institution?
- Can you provide the website URL of the institution?
- Is there a specific color code associated with the institution?
- What is the course fee?
- What is the estimated cost of living per month?
 - Collect all the details related to the above questions from either the Institute website or from the agency always referring to genuine information rather than from unofficial websites.

IV) Category: Funding and Sponsorship

- · Who is sponsoring your studies? What is your relationship with them?
- What is the source of funds for your living expenses?
- If it is a loan, what are the details such as interest rate, EMI, collateral, and repayment period?
 - Give proper answers to all the above questions, if there's a loan find all the available information like on repayment, total amount, duration, collateral, etc.





V) Category: Insurance

- Provide details about your insurance coverage, including the company,
 premium amount, coverage period, and coverage amount.
 - Candidates must have enough knowledge about the insurance coverage period, coverage, type of coverage, your insurance company
 name. Candidate must refer to the insurance details from the copy
 received while taking the policy.
- Why didn't you take coverage for the whole period of study?
 - Mention them you will be extending once over there in Malta.

VI) Category: Work Experience

- General information about your previous organization and its business.
 - Candidate must be capable of explaining the type of company businesses, job responsibilities, day-to-day duties, and responsibilities to prove the authenticity of the experiences.
- Your key responsibilities and position.
- Reporting system and communication with your reporting officer. 4.
 Salary, payment mode, and how you were paid.
- Why did you resign?
 - If you have a last experience with a maximum duration of less than 45 days then the candidate give the reason - "for pursuing an international program in Malta"
 - If the candidate has an employment gap then the answer must be professional and acceptable.





VII) Category: Overseas agency details

- 1. Who is your agent?
 - a. Give a brief about your agency.
- 2. Can you provide the website URL of the agency?
 - a. Website of your agency.
- 3. What is the email address of the agency?
 - a. Email id of agency.
- 4. How much did the consultant charge you?
- 5. What was the registration fee amount?
- 6. Can you specify the services included in the overall processing assistance, such as airport pick-up?
 - a. Brief about all the services the agency offered.
- 7. What services did the consultant provide?
 - a.Guidance, Institute, and Course search assistance, Information guidance about country and living.
- 8. Can you provide more details about the visa documentation support they offer?
 - a. Guidance and information support to Apply VISA. (Candidate should mention they will or have filled the application by themselves.
- 9. How did they assist you with guidance throughout the visa process?

 a. Learn a brief about VISA application filing and answer accordingly.





VIII) Category: Travel and Accommodation

- Can you provide the details of the flights you have booked or blocked for your travel?
- How did you book the flights?
- Can you mention the name of the airline(s) you have chosen?
- What are the routes for your flights?
- Do you know the rates of your flights?
 - Candidate must have enough knowledge in describing all the above questions as per the new guidelines the first landing EU country must be Malta.
 - Refer travel itinerary for more details, and the airline's online website to understand more details if needed.
- How did you book your accommodation? Where is it located? What is the monthly rate? How far is it from the institute?
 - If someone else helped you to find the accommodation then you need to collect all the above information. Note:- From the perspective of both the institution and the embassy, a candidate with an intention of study will do the complete processes by themselves.
 - Candidate must be aware of the distance from accommodation to the institute and possible travel options.
 - Candidates can use Google Maps, and other online sources to understand the locality and route.





VIII) Category: Future Plans after Studies

- What are your plans after completing your course?
 - Must be returning to the home country to pursue a job or to become an entrepreneur. Or else the candidate can explain as further study in any international country. The answer should not be settling in Malta or working in any other country.
- Do you have any specific career goals or aspirations?
- Are you planning to seek employment opportunities in Malta or another country?
 - The answer must be "NO" in all the cases and situations.
- Have you considered any further education or specialization in your field?
 - Prepare an acceptable answer this can be either "YES" or "NO" but the candidate must be capable of providing the necessary explanation.
- How do you plan to utilize the knowledge and skills gained from your course?
 - Either the candidate can explain as reaching a better position in the career or becoming an entrepreneur after gathering enough jobbased experience.
- Have you researched potential job prospects or opportunities in your desired field?
 - The answer must be yes and needs explanation depending on the chosen program
- Are there any specific industries or organizations you are targeting for employment?
 - The answer must be yes and needs explanation depending on the chosen program





VIII) Other Questions

- Are you eligible for a part-time job?
 - Yes, the Candidate must answer in a way that he/she is not interested in the part-time jobs as it may consume valuable study time, and you already have the living expenses with you.
- Will you consider taking up a job in Malta after completing your course?
 - No, as you have multiple good opportunities in your home country.
 Even if the salary in Malta is high, you can save more in your home country as the living expenses in comparitively very cheap.
- Did you consider any other institutions? If so, suggest another
- Institution and explain the advantages of your current institution.
 - Note: refer institute website to prepare points also candidate needs to compare similar courses with other institutes in Malta.
 - If the same course happens to be in another institute with a low fee, then candidates must prepare points focusing on the teaching quality level, other facilities, amenities, location, college ratings, testimonials, and Google reviews.
 - Refer to "about us" on the institution's website.
- How did you come to know about your institution?
 - You can say from friends, family, Online, etc.
- Did the institution conduct an interview? If yes, provide details.
 - Gather the answer from the agency
- What is your plan to recover the investment made in this course?
 - Pursuing a better career in of the best options or you can say that your major returns for the investment are your knowledge and international exposure.
