Consultant's Responsibilities:

3. The "Consultant" will put to use their expertise, knowledge and required efforts to assist in preparing the student admission application.
4. The "Consultant" charges a consultancy fee in accordance with their norms for assisting with the Student Admission Application. This fee covers various services including the processing costs for application apostille services, paper processing costs for academic credential evaluation with the concerned government authorities in the state of the applicant in India, paper processing and administrative costs incurred for the application for a temporary resident permit, shipment charges, notary attestation, legalization assistance, forged documents check and other miscellaneous charges in India to be borne by the student.
5. The "Consultant" will provide complete assistance for the Student Permit / Study Visa and the costs incurred for these services are non - refundable. The student is entitled for a refund of the 70% tuition fee of the first year fees of the study program at School of Advanced Social Studies (SASS) and the other costs are non- refundable. Any costs incurred for the admission, translation, TRP and other related services are non- refundable as these represent the actual costs.

Scope of Services:

6. The services of the "Consultant" to the student is only related and restricted to the admission process. The services do not extend to assist him/her with job placement, part time jobs, migration or settlement in countries where admission is sought.

Purpose of Education:

7. The student undertakes to be aware that he or she is going abroad only for the purpose of education and has been informed by the "Consultant" to confine himself/herself to only that specific purpose. Violation of this purpose would lead to breach of permit/visa and the student and/or their guardian/parents are fully aware and would be fully responsible for any consequences or adverse effects of the same.

Application Process:

8. The Student understands that the "Consultant" will apply for Fall 2024 intake for the course BA Social Management on behalf of the student which is opted by the Student. But in case, there is no formation of group in the coming session (Fall 2024) of SASS cancels the program for the Fall 2024 intake, the student can either wait for the next academic year or opt for the eligible refund .

This service fee is for the aforementioned enumerated services and the "Consultant" will not be responsible in case the student does not clear the conditions stated by the School of Advanced Social Studies(SASS) as stated in the provisional admission. Legal Consequences of Unauthorized Work:

10. The Student understands that work without authorization can lead to deportation and other legal problems. The Student is expected to have the funds for the full duration of the course tuition fee and living costs.

11. The students may seek part-time employment opportunities while studying abiding to the rules and regulations of the country. It is the responsibility of the students to ensure that their part-time employment does not interfere with their academic commitments and complies with the legal requirements of their student visa or temporary resident permit. The student is obliged to fulfill all the contractual obligations of the study agreement with School of Advanced Social Studies (SASS). The consultants cannot be held responsible for any issues arising from the student's failure to comply with these obligations or legal requirements.


13. The student is obliged to submit any additional documents as per the visa/TRP requirements updated by the embassy.

Visa Disclaimer

1) It is the responsibility of the student to submit the ORIGINALS of the non-academic documents at the consul / VFS and any negative decisions on visa upon not submitting the ORIGINAL documents or due to the forgery of the documents submitted shall not be the responsibility of Europe Study Centre.

2) It is OBLIGATORY that the complete checklist of documents including the COVER LETTER must be submitted to Head Office for the purpose of verification, and if the student carries any extra document without approval from the HO, is at the sole discretion of the student and HO cannot hold the responsibility for this document in case of visa refusal.

3) It is MANDATORY that the ordering and the verification approval of the visa checklist documents is obtained from the respective Processing Coordinator before the student is shared with the Visa Mediation Papers and appointment confirmation.

4) The student shall not be entitled for the tuition fee refund in case of visa refusal for the following reasons:

- forgery of the documents submitted for visa
- the student showing unwillingness to submit the additional documents requested by the embassy
- student showing unwillingness to submit the ORIGINALS of the non-academic documents and other prescribed documents as per the visa checklist
- Student submitting any extra document without the verification or approval from head office without any request from the consul/ VFS.
- Incomplete documents as per the checklist
- For Lithuania: All students have to undergo check and verify service.
