EMŠO je osebna identifikacija številka v Republiki Sloveniji. Vpisuje se v uradne evidence in druge zbirke podatkov, če je tako predpisano z zakonom, upravljavec pa je dolžan navesti zakonsko podlago. Če zbiranje EMŠO ni določeno z zakonom, se sme pridobiti od posameznika samo s pisno privolitvijo, pri čemer je upravljavec evidence posameznika dolžan seznaniti z namenom, podatke pa sme uporabiti samo za ta namen in jih ne sme posredovati drugi osebi. V nasprotnem primeru se to lahko kaznuje kot prekršek.

The EMŠO is a personal identification number in the Republic of Slovenia. It is entered in official records and other databases when so stipulated by the law. The record or database manager is obliged to state the legal basis. If EMŠO collection is not stipulated by the law, an EMŠO may only be obtained from a person on his/her written consent. In the event of such, the record manager is obliged to inform the person of the purpose, may only use the data for that purpose, and may not pass these data to another person. Otherwise, this is punishable as a minor offence.
