Based on Article 38a of the Act on Higher Education (ZVis, Official Gazette of the RS, No. 32/12 - Official consolidated text, 40/12 - ZUJF, 57/12 - ZPCP-2D, 109/12, 85/14, 75/16, 61/17 - ZUPŠ, 65/17, 175/20 - ZIUOPDVE, 57/21 - Decree of the US, 54/22 - ZUPŠ-1, 100/22 - ZSZUN and 102/23), Article 20 and Article 37 of the Statute of the Faculty of information studies in Novo mesto (Ur. 51/21), the Call for Enrolment to the Master's Degree Programme in Cyber Security in the Academic Year 2024/2025 (hereinafter referred to as the Call), Article 43 of the Regulations on the Call for Enrolment and the Conduct of Enrolment in Higher Education (Official Gazette of the RS, No. 6/22, 4/23 and 7/24), and Decision No. 20-3-17 of the Commission for Academic and Student Affairs (hereinafter referred to as the CSSA), adopted at the 20th meeting on 18. 7. 2024, the Faculty of Information Studies in Novo mesto issues the following

DECISION

1. **Sreedev Poomuttikudy Reji**, Kurichilakkod, Kodanad Po, Ernakulam, 683544 Ernakulam, Kerala, India, meets the requirements for enrolment to the first year of the part-time Master's degree programme Cyber Security, but must complete the following four bridging exams before enrolment (based on the programme of the previous education on the bachelor level of studies):
 - **Introduction to Programming,**
 - **Computer Networks,**
 - **Operating Systems** and
 - **Information Systems.**
2. The candidate Sreedev Poomuttikudy Reji is granted **a subsequent enrolment, until 30. 10. 2024 at the latest.**
3. There were no costs incurred in the proceedings.

Explanation:

The candidate Sreedev Poomuttikudy Reji applied for enrolment in the first year of the part-time Master's degree study programme Cyber Security, in the first application period, which was open from 1. 4. 2024 to 30. 4. 2024.

The call for enrolment specifies that the following individuals can be enrolled in the first year of the master's study programme Cyber Security:

- who has completed a bachelor's study programme in the fields of informatics or computer science. The competent faculty authority does not prescribe additional study obligations based on the application for enrolment;

- who has completed a bachelor's study programme in the fields that belong to the study fields of social sciences, journalism and information science, business and administrative sciences, law and from the fields of natural sciences, mathematics and statistics. Based on the application for enrolment, the competent faculty authority prescribes additional study obligations to the candidate in the range of 24 ECTS;
- Who has completed a bachelor's study programme in other fields of study. Based on the application for enrolment, the competent faculty authority prescribes additional study obligations to the candidate in the range of maximum 30 ECTS;

At its 20th meeting, on 18. 7. 2024, the CSSA considered applications for enrolment. The applicant graduated from Jain Deemed-to-be University, India, from study programme Bachelor of Science, Forensic Science and is therefore required to complete the following bridging exams: Introduction to Programming, Computer Networks, Operating Systems and Information Systems.

Article 43 of the Regulations on the Call for Enrolment and the Conduct of Enrolment in Higher Education (Official Gazette of the RS, 6/22, 4/23 and 7/24) states that applicants who, for justified reasons determined by the competent authority of the higher education institution, were not able to enrol within the regular deadlines may be allowed to enrol by the competent authority of the higher education institution after the expiry of these deadlines, but no later than 30 October.

Since the accepted candidate must pass bridging exams before being enrolled, he is granted subsequent enrolment in accordance with this Article by 30. 10. 2024 at the latest.

INSTRUCTION ON LEGAL REMEDIES:

This decision may be appealed within 15 days of its notification. The appeal should be sent in writing by registered post to the address of the Faculty of information studies in Novo mesto, Ljubljanska cesta 31a, 8000 Novo mesto, p.p. 603. The Senate of the Faculty of information studies in Novo mesto will decide on the appeal.
