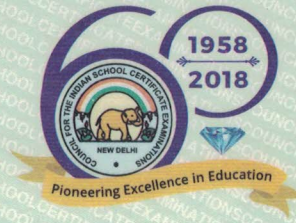



## EXPLANATORY NOTE

### I. EXTERNAL EXAMINATION

Attainment in a subject is indicated by a percentage mark.

### II. INTERNAL ASSESSMENT

The standard attained in Socially Useful Productive Work & Community Service, abbreviated on the face of the Statement of Marks as SUPW & COMMUNITY SERVICE, is indicated by a letter grade, of which Grade A is the highest and Grade E the lowest. The interpretation of the grades is as follows:

Awards and conditions for awards:
